

## Phenomena identified in the Nakło nad Notecią commune.



- Decreasing population (by 2.6% in the examined period) and unfavourable forecasts (decrease by 3.6% by 2030).
- Decreasing birth rates and permanently unfavourable migration balance.

- Weakness of the labour market (economic emigration), low level of development and attractiveness of the local labour market.
- 6 Low level of professional activity of women and young adults.
- Diversified settlement structure, an urban-rural nature of the commune.
- 8 Increase in the number of enterprises by 2.5% in the examined period.





- 9 Functioning of the Nadnotecki Industrial Park in Paterka.
- Activity of big business enterprises, such as the Nakło Sugar Processing Plant or the "PATEREK" Railway Rolling Stock Repair Works.

  a rich and competitive leisure offer on the basis of a new and revitalised public
  space, sports infrastructure and recreational and socio-cultural activities offer.

#### **ENHANCEMENT OF INVESTMENT ATTRACTIVENESS**

- **8** Construction of an integrated system of bicycle trails.
- 9 Modernisation of the infrastructure along Dąbrowskiego street in the section from Konopnicka square to Bydgoska street including surface renovation and change in traffic organisation.
- 10 Modernisation of Powstańców Wielkopolskich street returning the street to residents.

- 1 Support for the creation and functioning of nurseries and kids' clubs.
- 2 Undertaking activities aimed at increasing the activity of disabled people living in the town and commune.

- **4** Further modernisation and expansion of the educational base.
- 5 Increasing the quality and effectiveness of education and the attractiveness of teaching.
- **6** Promoting access to city education and providing equal educational opportunities.
- 7 Developing a senior citizen policy.

- 9 Extension of swimming pool service offer and facilities to accommodate rehabilitation services.


#### DEVELOPING AN ATTRACTIVE, THEMATICALLY BALANCED LEISURE OFFER
